Guidelines

When engaging on social media platforms, we ask that you adhere to the following guidelines:

- Respect all of our staff and players
- Respect fellow fans and opposition supporters
- Respect the match officials and the decisions they make during a match
- Do not place yourself or others in danger
- Remember that your comments will be seen by children and young people
- Refrain from any discriminatory language, opinions, videos or pictures. This includes homophobic, Islamophobic, Antisemitic, Racist, Sexist and abusive comments, or any

discriminatory language by means of race, religion or belief, gender, sexual orientation, disability, colour or national or ethnic origin.

Actions

Should a person be found to contravene the above guidelines and we are able to identify the person concerned, the Club will instigate the disciplinary process.

Actions, dependant on the circumstances and at the discretion of the club can include:

- Reporting to the social media platform used
- Reporting to the police
- Banning from matches
- Reporting to the Premier League

Any actions will be at the sole discretion of the club.
